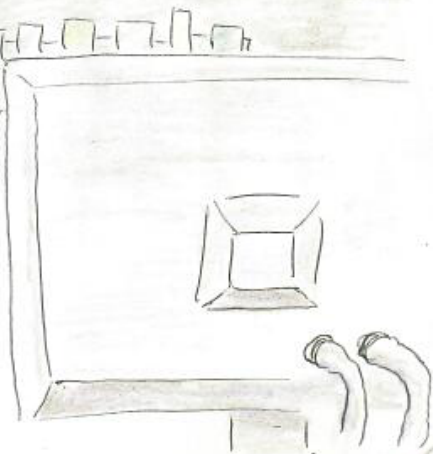

WHATEVER IT TAKES TO KEEP MY JOB AND MY SPORTS CAR!

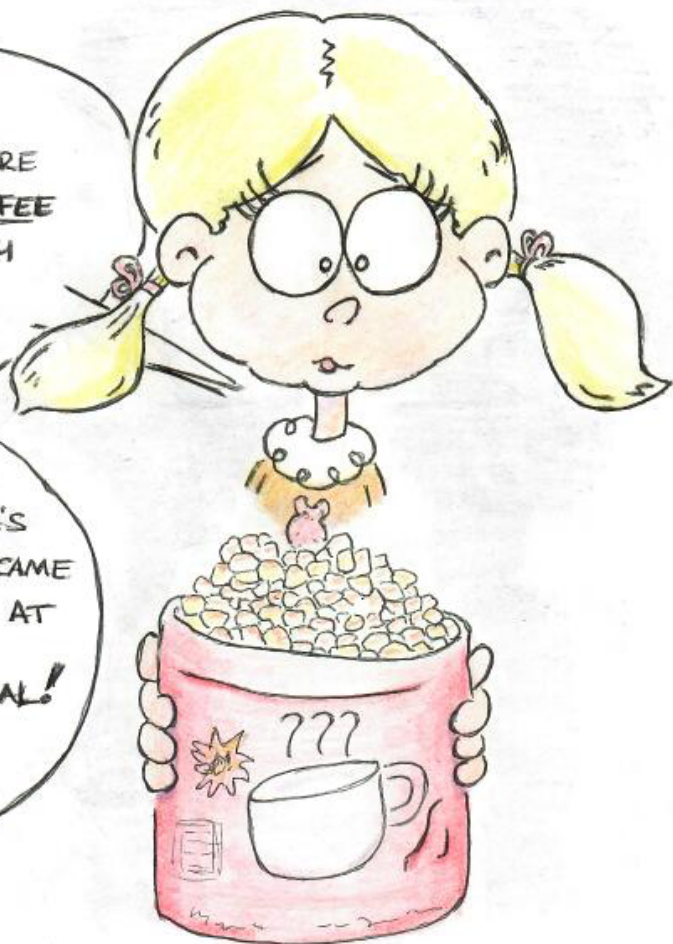

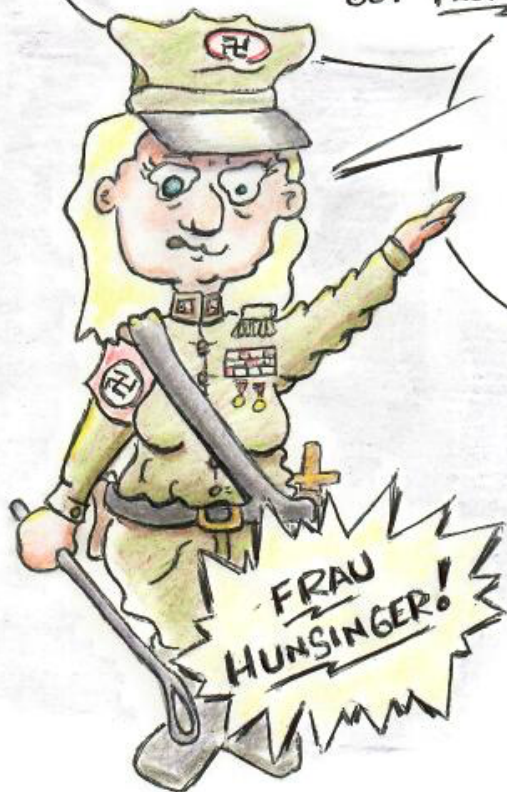




## INVESTIGATOR ANGELA M. HUNSINGER...

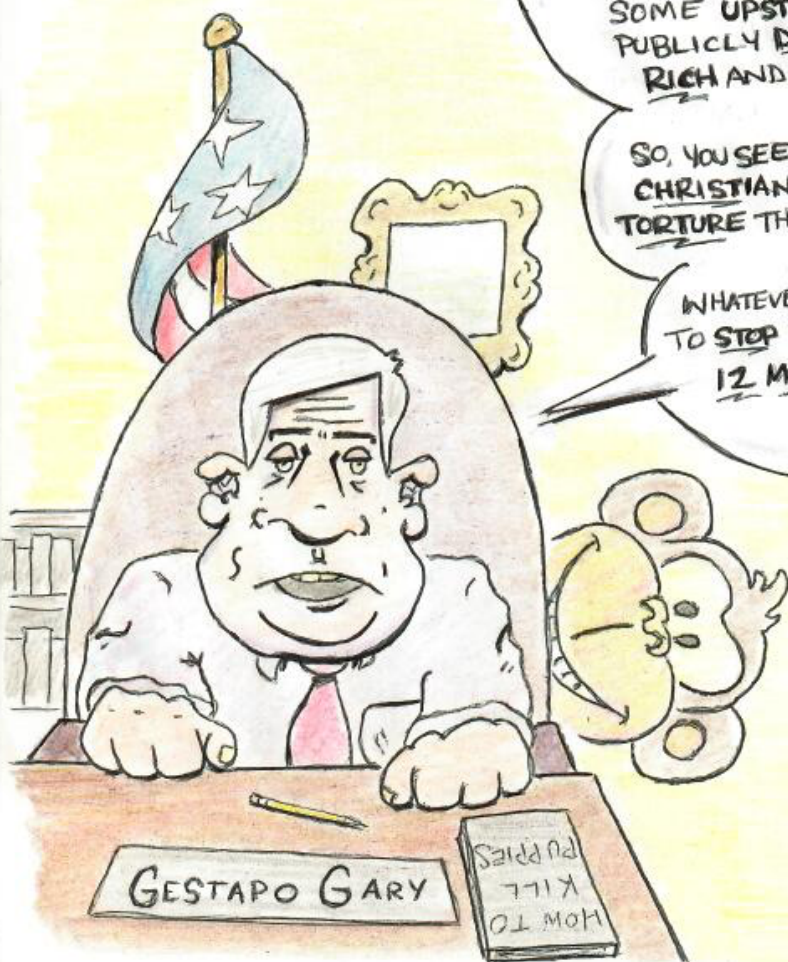
... AND MY PREDECESSOR, FORMER C.C.A. LOBBYIST GARY C. MOHR...

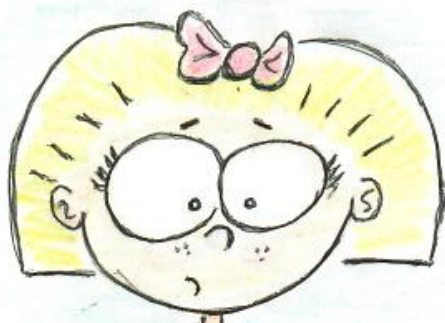

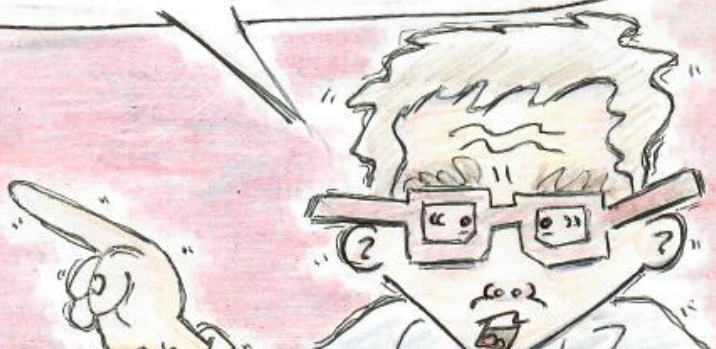


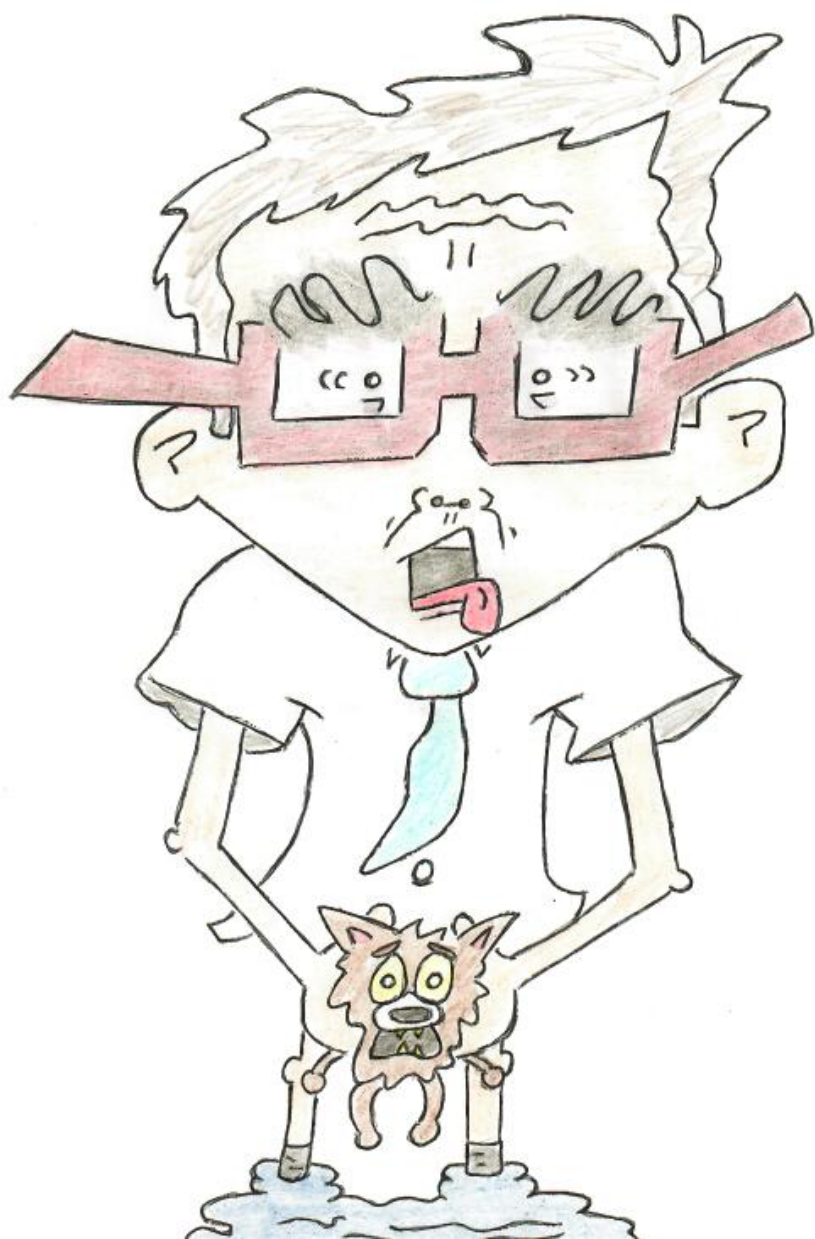

...COULD WE HAVE PREVENTED THE CAPITOL RIOTS? SURE...

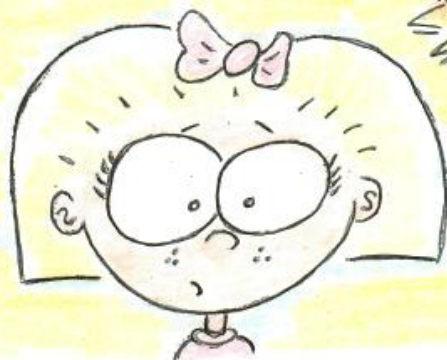

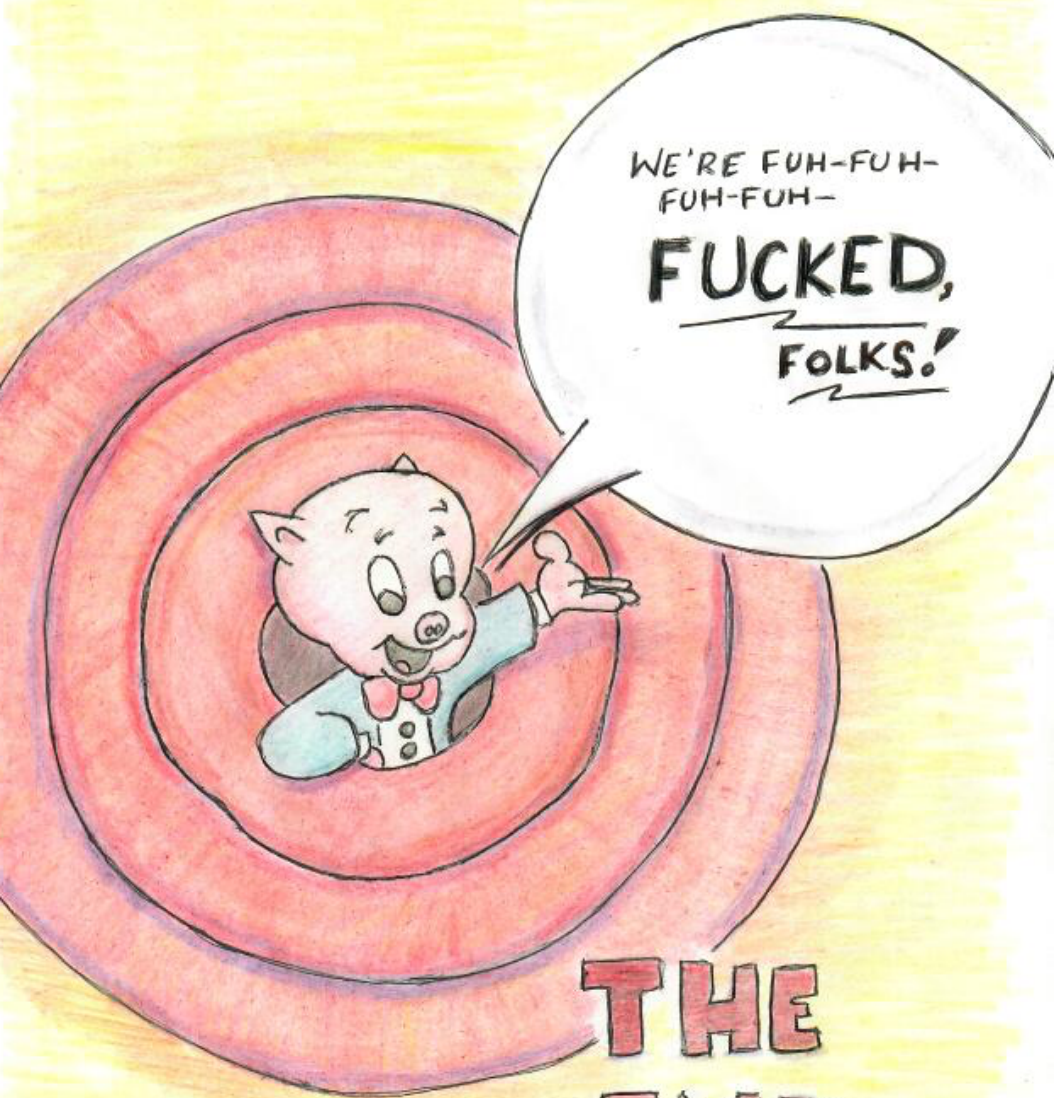

## ABOUT ANARCHIST PRISONER SEAN SWAIN




SEAN IS THE ONLY CHILD OF A FACTORY WORKER AND A STAY-HOME MOM. HE HAS AN HONORABLE DISCHARGE FROM THE U.S. ARMY AND EARNED A WRITING SCHOLARSHIP FOR COLLEGE. IN 1991, THE NEPHEW OF THE CLERK OF COURTS BROKE

INTO SEAN'S HOME AND SEAN KILLED HIM IN SELF-DEFENSE. SEAN WENT ON TRIAL FOR MURDER, AND WHEN HIS CONVICTION WAS REMANDED BY THE COURT OF APPEALS, THE TRIAL COURT REFUSED TO GIVE SEAN THE FAIR TRIAL AS ORDERED. SEAN REMAINS CAPTIVE FOR 3 DECADES WITHOUT A LEGAL CONVICTION OR SENTENCE.

SEAN WROTE OHIO AND OPPOSING TORTURE, AND CO-WROTE LAST ACT OF THE CIRCUS ANIMALS, ALL AVAILABLE FROM LITTLE BLACK CART. HIS WEEKLY COMMENTARIES APPEAR ON THE FINAL STRAW RADIO SHOW, AND THE LABADIE COLLECTION AT THE UNIVERSITY OF MICHIGAN ARCHIVES HIS PERSONAL PAPERS AND AFFECTS.

IN RESPONSE TO SEAN'S OUTSPOKEN CRITIQUE OF THEIR CRIMES AND CORRUPTION, OHIO PRISON OFFICIALS AND THE FBI HAVE TORTURED, SEXUALLY ASSAULTED, BLACKSITED, RENDITIONED, AND EVEN PLOTTED TO KILL SEAN - UNSUCCESSFULLY.

UNFORTUNATELY FOR THEM, HE'S STILL BREATHING.
